NOTICE IS HEREBY GIVEN that pursuant to the resolution duly adopted by the Board of Fire Commissioners of the Apalachin Fire District, in the Town of Owego, Tioga County, New York, a Special Election of the qualified voters of said Fire District, will be held at the Apalachin Fire House, 230 Pennsylvania Avenue, Apalachin, New York, on March 16, 2010, at 12:00 P.M. (Prevailing Time) and the polls shall remain open until 9:00 P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes upon the following Proposition:

PROPOSITION

SHALL the bond resolution of Apalachin Fire District, in the Town of Owego, New York, entitled: "BOND RESOLUTION OF APALACHIN FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF OWEGO, TIOGA COUNTY, NEW YORK, ADOPTED JANUARY 12, 2010, AUTHORIZING THE CONSTRUCTION OF ADDITIONS AND/OR ALTERATIONS AND IMPROVEMENTS TO THE EXISTING APALACHIN FIRE STATION, INCLUDING DEMOLITION, RENOVATION AND NEW CONSTRUCTION ("PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$4,500,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND THE FINANCING THEREOF; APPROPRIATING SAID AMOUNT THEREFOR; AUTHORIZING THE ISSUANCE OF SERIAL BONDS IN THE AMOUNT OF NOT TO EXCEED \$4,500,000 TO FINANCE SAID APPROPRIATION; STATING THAT THE BOARD OF FIRE COMMISSIONERS, ACTING AS LEAD AGENCY PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT, HAS DETERMINED THAT THE PROJECT IS AN UNLISTED ACTION AND A NEGATIVE DECLARATION HAS BEEN ISSUED AND FILED; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF THE NEW FIREHOUSE IS TWENTY-FIVE (25); YEARS, AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS

AND THE INTEREST THEREON AS THE SAME BECOME DUE AND
PAYABLE," BE APPROVED?
